## NOTICE OF PUBLIC HEARING – July 8, 2016

In accordance with Supreme Court Rule 3 (Rulemaking Procedures), you are hereby notified that the Supreme Court Rules Committee will hold a public hearing on **Friday, July 8, 2016**, beginning at **10 a.m.**, in Room C-500 at the Michael A. Bilandic Building, 160 N. LaSalle Street, in Chicago. Clerks of court are requested to post a hard copy of this notice in a conspicuous place.

The public hearing agenda includes the following items:

**Proposal 15-02 (P.R. 0227) - Amends Supreme Court Rule 12 (Proof of Service in the Trial and Reviewing Courts; Effective Date of Service)**

The Rules Committee seeks comments on a proposal to amend paragraph (b) of Supreme Court Rule 12 to replace the word "affidavit" with "certificate" and to include reference to section 1-109 of the Code of Civil Procedure.

**Proposal 15-05 (P.R. 0230) – Amends Supreme Court Rule 941 (General Provisions) and Creates Supreme Court Rule 943 (Use of Restraints on a Minor in Delinquency Proceedings Arising Under the Juvenile Court Act)**

The Rules Committee seeks comments on a proposal to amend Supreme Rule 941 to provide that the rules apply to all juvenile delinquency proceedings filed under article V of the Juvenile Court Act of 1987. The proposal also would create Supreme Court Rule 943 to address the use of restraints on a minor in delinquency proceedings arising under the Juvenile Court Act.

**Proposal 15-06 (P.R. 0231) - Amends Supreme Court Rule 307 (Interlocutory Appeals as of Right)**

The Rules Committee seeks comments on a proposal to amend Rule 307 to authorize the filing of Rule 328 supporting records, instead of full records on appeal, in Rule 307 appeals; to provide that, in interlocutory appeals authorized under Rule 307, the notice of appeal shall be filed in the circuit court; and to provide that Rule 373 may be utilized in Rule 307 appeals, provided that the relevant documents are sent by overnight delivery.
